Introductions and Etiquette

Elections-

- Roles and Responsibilities
- Still Need:

 - €.●.2. ESOL Rep but their meetings conflict with ours, which might be a challenge to place

Subcommittees and other BCPS Committees-

- Grade Level (Elementary, Middle, HS), Zoning & Enrollment, Curriculum & Programs, Policy & Bylaws, Outreach
- Jody will be at our meeting this month Aug 31st for Reproductive Health Presentation. In the presentation the stuff in red/orange is the supplemental stuff they want to add and need our feedback on. They also have a survey they want everyone to complete to give feedback. This goes to the board October 12th. Parents can't opt out of Reproductive Health because it falls under "Science" however, they can opt out of supplemental. The main reason parents DO opt out is "Well, I don't know what they're teaching my children." Cynthia brought up the point that schools should notify parents of WHEN this curriculum is covered so that parents can follow-up with their children, see if they have questions, etc.
- We will allot 1 HOUR in our agenda August 31st for this Presentation, Q&A's
 - Proposed changes:
 - The law requires us to preach abstinence, but there's nothing that keeps up from talking about prevention, so thinking that we this will be added.
 - From K-2
 - they use medically accurate names for the private parts.
 - Personal safety such as safe and unsafe touches including "private parts"
 - Teaching the definitions for domestic violence, sexual abuse, sexual harassment
 - From 3-5 Students right related to their physical rights.
 - Cyber-bullying
 - Puberty in both males and females (menstrual cycles), but it excludes actual sex and gender identification

- 6th Grade: Self Esteem, Grooming and Boundaries, Fitting In, Isolation, contraceptives and birth control
- 7th Grade: Abstinence, STDS/Infections, Contraceptives and Birth Control
- HS is pretty much the same
- EPAC, Discipline, Waivers, Calendar, Transportation, DAC/DAC seats
- Legislative Updates (need John to confirm for our Mtg Aug 31st)
 - €.●.1. NEW Name Requirements for Students: Nicknames and pronouns other than legal name/sex need to be signed by parent.
 - €.●.2. Cell Phones: Is this up to the schools to decide? Or is it district? This is in our Code of Conducts, which technically needs to be reviewed annually.
- FAST/iReady Updates
 - iReady for Reading, Math, & Fluency teachers like this because it gives a lot of data for assessing. It's a really good teacher tool. It's good for the data.
 - FAST has paper accommodations for ESE/IEP
